### 4. FIRST AID MEASURES

#### Eye contact

Immediately flush eyes with plenty of cool water for at least 15 minutes. Get medical attention if irritation occurs.

#### Skin contact

Remove contaminated clothing. Wash area with soap and water. If irritation occurs, get medical attention.

#### Inhalation

If inhaled, removed to fresh air. Get medical attention if symptoms appear.

#### Ingestion

Rinse mouth. Do not induce vomiting. Never give anything by mouth if victim is unconscious, is rapidly losing consciousness, or is convulsing. Seek medical attention or contact local poison control center.

### 5. FIRE FIGHTING MEASURES

#### Suitable extinguishing media

Carbon Dioxide, foam, dry chemicals extinguishers should be used. Do not use water.

#### Unsuitable extinguishing media

Water spray, water jet.

#### Special protective equipment and precautions for fire-fighters

Self-contained breathing apparatus and protective clothing should be worn when fighting fires involving essential oils or chemicals.

### 6. ACCIDENTAL RELEASE MEASURES

#### Personal precautions, protective equipment and emergency procedures.

Use of self-contained breathing apparatus is recommended for any major chemical spill. Refer also to section 8. Eliminate all ignition sources. Ventilate area. Determine the need to evacuate or isolate the area according to your local emergency plan.

#### Environmental precautions

Keep away from drains, surface and ground water. Report spills to appropriate authorities if required.

#### Methods and materials for containment and cleaning up

Contain and collect with inert absorbent material and place in suitable container for disposal. Comply with all federal, state, and local regulation. Wipe small spills with cloth. Clean with hot water and detergent.

### 7. HANDLING AND STORAGE

### Precautions for safe handling

Avoid inhalation and contact with skin and eyes. Good personal hygiene practices should be used. Wash after any contact, before breaks and meals, and at the end of the work period. Contaminated clothing and shoes should be cleaned before re-use.

### Conditions for safe storage, including any incompatibilities

Containers should be kept closed in order to minimize contamination. Store in a cool, dry, well ventilated place protected from light. Keep away from extreme heat and from freezing conditions and away from all sources of ignition. Make sure the material does not come into contact with substances listed as 'Materials to Avoid'.

## 8. EXPOSURE CONTROLS AND PERSONAL PROTECTION

---

### Eyes

The use of safety glasses is recommended. If a material is to be handled in a manner where splashing may occur, the use of splash goggles or face shield is recommended

### Skin

Using chemical resistant gloves and clothing is recommended.

### Respiratory

In well ventilated areas, respiratory protection is not normally required. In confined, poorly ventilated areas the use of NIOSH approved respiratory protection normally required (use only if trained in proper use and with acceptable oxygen level).

### Control parameters

An eyewash fountain and/or safety shower should be available in the work area. Acceptable industrial hygiene practices should be maintained. These precautions are for room temperature handling. Use at elevated temperatures or aerosol spray applications may require additional precautions.
